

# Responding Proactively or Punitively: Rethinking Prosecution by Service Providers of Those They Serve

People with mental health issues receiving services across a range of institutional settings increasingly face the possibility of being arrested and criminally charged for behaviors for which the program is designed to provide care. We will spend the day examining the problem of assaults and arrests, and learning about programmatic and advocacy responses that can help improve the situation for both the clients/patients and their service providers.

Youth face this problem in schools, often initiated by a school resource or police officer or by a school administrator, or in residential programs, where vendor staff or administrators may press charges after an incident during a restraint or similar incident. Adults experience this problem in hospital emergency rooms and psychiatric inpatient units, where staff may press charges on their own or at the directive of administrators when a patient acts out. It is also a problem in Massachusetts prisons where DOC must report all felonies to the DA and in jails where some sheriff departments pursue charges as a means of discipline and control.
