On behalf of the American Civil Liberties Union- MA, the Center for Public Representation, the Disability Policy Consortium, Mental Health Legal Advisors Committee, Greater Boston Association of Black Social Workers, and the National Association of Social Workers- MA we would like to extend our gratitude for everything you and your teams do to support all Massachusetts citizens, particularly those from the most marginalized and underserved communities.

At this time, we respectfully request that you support the matching grant program **Equitable Approaches to Public Safety (EAPS) operated out of the Department of Public Health at \$3.61 Million** in the FY24 House Ways & Means budget. Matching grants for Equitable Approaches to Public Safety (FY23 line-item 4512-2020) are used to implement alternative response models for nonviolent mental and behavioral health crises by dispatching community-based teams of providers and peers instead of or alongside law enforcement. Preference is given to models using unarmed responders. Now in its second year, the EAPS program has garnered more than a dozen municipal applications for funding, with awards being used to implement programs in *Brockton, Gardner, Winthrop, Revere, Lawrence, Salem, New Bedford, Amherst, Norwood, Stoughton, Northampton.* and *Tewksbury.* The communities you represent rely on these grants to provide this crucial service.

Expanding access to voluntary community-based crisis services and alternative emergency response strategies achieves several critical public policy goals: reducing law enforcement use of violence, diverting those in need of behavioral health interventions from incarceration to community services, and promoting more equitable outcomes for individuals with psychiatric conditions, including those from historically marginalized communities.

Matching grant funds are critical to the continuation and development these programs, as access to funding is scarce, especially for lower-income municipalities. Contrary to the language

in the Governor's FY24 budget proposal, this funding was never intended to be a onetime disbursement, but rather an ongoing investment. Community-based crisis-response models are endorsed by a wide array of organizations and have been successfully implemented in numerous cities and towns nationwide. Massachusetts routinely leads the nation in compassionate and equitable policymaking, let us continue to do so in this lifesaving work.

We respectfully request you support at least level funding for Line-Item 4512-2020 Equitable Approaches to Public Safety program at \$3.61 Million. By dedicating funds in FY24 for alternative response models, and continuing to designate a preference for community based, unarmed responder models, the legislature can empower municipalities to implement responses tailored to and by their communities.
